### **WEGA Committee – the present perilous situation**

As in the No 48, Spring 2010, Newsletter the then Secretary, Graeme Churchard, drew attention to a crisis in that the group had been without a field secretary for a number of years and that he was resigning his positions of Secretary and Newsletter editor. There had been no nominations or volunteers to take on those roles. Although at the last minute Alan Insole volunteered to be Secretary, it has not been possible for him to continue in that role. Thus we once again have a repeat of the situation in that the group finds itself with some of the main committee positions being unfilled.

The constitution requires that notification of nominations for Committee officers must be with the Secretary by the end of February, if they are to be included in the AGM agenda. Once again there have been no nominations for any committee member. However, it is possible for Ordinary members of the committee to be nominated from the floor at the AGM, and subsequently co-opted a officer position. *New office members are essential through this route if WEGA is to remain a viable organisation.*

### **THE POSITION OF WEGA IN THE ABSENCE OF NEW COMMITTEE MEMBERS**
